




For blockchain to unleash its full potential, different technical preconditions need to be met, making it a medium- to long-term solution

Short-term: centralized solution



Mid-term: decentralized validation server



Benefits: all architecture components available today


Assumptions: centralized server and single point of failure risk is not a problem

Benefits: single point of failure risk and dependance on central server significantly reduced

Assumptions: Vehicles can have an in-built processing layer and a private key embedded via OEMs

Potential PoC: Simulate vehicle alerting & processing via vehicle simulation software

Long-term: vehicle-to-vehicle communication



Benefits: Fully decentralized solution with no single point of failure

Assumptions: Vehicle-to-vehicle communication for alerting is technically possible and embedded via OEMs


